The wording for a Gift \* to the churches should be "I give <the Gift> free of all taxes to the Parochial Church Council of the parish of Brook with Mottistone in the Diocese of Portsmouth for its general purposes at the discretion of the incumbent, and I declare that the receipt of an officer of the Parochial Church Council shall be a sufficient discharge to my executors and trustees".

\*The main types of Gift are:

a specific sum of money (**pecuniary**)

a share in, or all of, what's left of the value after family legacies have been paid and debts settled (**residuary**)

a gift to your spouse, partner, or family member for their lifetime and afterwards to the church (**reversionary**)

### Gift Aid it
